- **GOOD CHARACTER REQUIREMENT:** One of the requirements stipulated by the UK Home Office is that the applicant must ensure that they have met the “good character requirement” by showing due regard for the laws of this country. Failing to do so may result in your application being refused. Please note that your application may be refused for the following:
  - Being convicted of a non-custodial offence or cautioned in the last 3 years.
  - Being sentenced to a period of imprisonment of 4 years or more.
  - Being sentenced to between 12 months and 4 years imprisonment unless 15 years have passed since the end of the sentence.
  - Being sentenced to less than 12 months imprisonment unless 7 years have passed since the end of the sentence.
- The package (completed application & supporting documents) will need to be addressed to the Office of the Deputy Governor & placed in the drop box on the 1<sup>st</sup> floor of the GAB.
- If the application and other supporting documents are not in order, the application will not be processed and will be returned to the sender.
- The processing time for a British Registration application is between **6-12 months**. Once it has been processed, you will be contacted and advised on the outcome of your application.
- Fees are subject to change without notice and are **non-refundable**.
